In the matter of: CWP No. 10919/2024 -titled as Prateek Kumar, Vs. State of H.P. & others.

Whereas, Sh. Prateek Kumar, TGT (NM) preferred CWP No. 10919/2024 titled as Prateek Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Motla, U/C GSSS Dhulara, Distt. Chamba, H.P to nearby home station in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 25-09-2024, when the Hon'ble High Court has passed the following orders:-

3. "Having heard learned counsel for the petitioner, this petition is disposed of with the direction that when general transfers are undertaken by the Education Department, to the Government of Himachal Pradesh, the petitioner be transferred out of his present place of posting and if possible, at a station of his choice or some other nearby station on priority basis. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 06-12-2024. He attended the same and submitted his representation in this office on 06-12-2024, vide which he has requested that he may be transferred from GMS Motla, U/C GSSS Dhulara, Distt. Chamba, H.P. to nearby native place in Distt. Kangra, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Motla, U/C GSSS Dhulara, Distt. Chamba, H.P., w.e.r 26-08-2021 and has completed the normal tenure of three years at present place of posting. One Sh. Nutan Chand TGT(NM) is working in GSSS Saloh, Distt. Kangra, H.P since 03-10-2023. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and he is hereby transferred without TTA/JT from GMS Motla, U/C GSSS Dhulara, Distt. Chamba to GSSS Saloh, Distt. Kangra, H.P. vice Sh. Nutan Chand, TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Nutan Chand, TGT(NM). The representation of the petitioner is disposed of accordingly.
