In the matter of:

CWP No. 8617/2025-titled as Anita, TGT (Med.) V/s. State of Himachal Pradesh and others (Regarding Transfer).

The Petitioner, Smt. Anita TGT(Med) filed CWP No. 8617/2025 titled as, Smt. Anita Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMSSS, Dand Distt. (Cba.) to Distt. (Kangra). The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 19.05.2025 when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

*Petitioner's only grievance is that on completion of three years at GMSSS Dand, District Chamba, she has preferred representation dated 11.03.2025 (Annexure P-1) seeking her adjustment due to adverse family circumstances, to the respondents/Competent Authority, however, the said representation has not been considered by the Competent Authority till date."*

*Looking to the limited grievance of the petitioner this writ petition if disposed of by directing respondent No.2/Competent Authority to consider and decided the aforesaid representation of the petitioner in accordance with law and as per applicable notification/policy within a period of three weeks from today. The decision so taken be also communicated to the petitioner. Pending miscellaneous application(S), if any, also stand disposed of.*

In compliance to the aforesaid orders passed by the Hon'ble High Court the petitioner was called for personal hearing on dated. 21.06.2025 but she could not attend the same due to her health issue during the travel. The petitioner has represented through her advocate to this office that she may kindly be adjusted at GSSS, Palampur, GSSS, Bhagotta, GSSS, Kandwar, GSSS, Matour, GSSS, Paprola GHS, Arth, GSSS, Kherian Distt. (Kangra) H.P.

From the perusal of record, it is found that Smt. Anita TGT (Med.) is working in GMSSS, Dand Distt. (Cba.) since 22.02.2022. GMSSS, Dand Distt. (Cba.) falls in Soft area of Distt. Chamba.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience. Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.

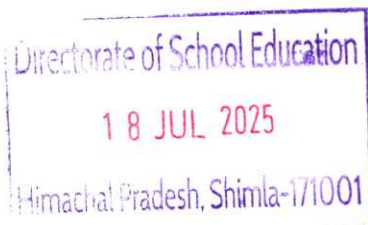
