OFFICE MEMORANDUM

In supersession of all previous order-s issued from time to time for filling up vacancies and in pursuance of the orders passed by the Hon'ble Supreme Court in the case: Excise Suprintendent V/S K.B.N.Visveshwara Rao 1996 (6) Scale dated 22nd August, 1996 (Other than those vacancies which fall under the perview of Himachal Pradesh Public Service Commission and Himachal Pradesh Subordinate Services Selection Board) in Government Departments, Public Sectors Undertakings, Boards, Corporations and Urban Local Bodies, the Governor, Himachal Pradesh is pleased to order that the following procedure shall be adopted for making recruitment: -

(a) Employers shall notify vacancies to Employment Exchanges of H.P. on the prescribed performa, as per provisions of the Employment Exchanges (Compulsory Notification of Vacancies) Act, 1952 and the Employment Exchanges (Compulsory Notification of Vacancies) Rules, 1960. In addition to this the employer should also invite open applications for which, keeping in view administrative/budgetary convenience, employers should arrange to make adequate publicity by way of publication of vacancies in Giriraj, published by the Information and Public Relations Department, H.P., broadcasting through All India Radio, Shimla, display of vacancies on office notice boards etc. The employers shall then consider the cases of all registrants sponsored by Employment Exchanges and who have applied directly.

(b) The instruction at (a) above shall not however be applicable to posts to be filled by Himachal Pradesh Public Service Commission, Himachal Pradesh Subordinate Services Selection Board, appointment to Class-III and IV posts of wards of Govt. Servants who die in harness, such posts as may be notified by the State Govt. from time to time and posts which are filled through the normal promotion channel.


These orders will take effect from the date of issue and will not apply to such cases where process of recruitment through Employment Exchanges/open advertisement has been initiated before the date of issue of this notification.
