OFFICE MEMORANDUM


Subject: Norms for fixation of emoluments of whole time contingent paid employees-clarification regarding.

In partial modification of this Department's OFFICE MEMORANDUM No. FIN(C)B(7)-57/80-IV dated 18th May, 1994, and in supersession of this Department's letter No. Fin-(PR)B(7)-15/98 dated 30th May, 1998 the undersigned is directed to say that the matter regarding determining the rates of emoluments/wages was engaging attention of the Government for the some time past and after careful consideration, it has been decided that the emoluments/wages of the employees engaged as whole time contingent paid, shall be determined w.e.f. 1st August, 2006 in the manner prescribed below:

1. Minimum of the pay scale admissible to Class-IV staff on regular establishment. Presently the minimum of the pay scale admissible to Class-IV is Rs. 2520/-P.M.
2. Since Dearness Allowance equal to 50% of existing pay has been merged with basic pay in respect of Government employees including Class-IV, as such an amount appropriate to 50% of the minimum of pay scale i.e. Rs. 1260/- may also be taken into account i.e. Rs. 2520+ 1260/- = Rs. 3780/- and DA may be worked out on the amount i.e. Rs. 3780/-.

Other terms and conditions as prescribed in Office Memorandum No. Fin(C)B(7)-57/80-IV dated 18th May, 1994 shall remain unchanged and the emoluments so determined shall remain static for a financial year.


