Subject: Court Orders-Implementation thereof.

It has been observed in several cases that the orders passed by the Courts in various Writ Petitions/Judgments involving financial implications including matters relating to grant of higher pay scales/back wages, regularisation etc., are not handled/dealt with on priority basis by the concerned departments as well as at the Secretariat level and the cases are referred to the Finance department almost at the expiry of the period specified by the Hon'ble Court for implementation of the Court orders. In such circumstances, the Finance Department finds it difficult to examine the cases in the right perspective given the financial implications involved. In several cases prior consultation with Law Department on legal aspects too is required to be done by the departments.

It is requested that the departments/Officers working under your administrative control may be asked to deal with such matters on a priority basis and in cases where concurrence/advice of the Finance Department is required, the matter may immediately be sent by the concerned Administrative Department to the Finance Department to avoid delay in finalizing the State Government response to the orders of the Courts.



All the Administrative Secretaries are requested to ensure that a mechanism is developed in the departments under their control to deal with such cases on "TOP PRIORITY BASIS" which may be referred to the Finance department within 15 days of the receipt of orders from the Court, complete in all respect i.e. background of the case alongwith previous papers/orders, number of beneficiaries, additional financial implications etc.

All Head of the Departments may also take necessary action in the matter to ensure timely disposal of Court matters and the orders passed by the Hon'ble High Court.

This may be brought to the notice of all concerned.
