## TERMS AND CONDITIONS:-

1. The above rates are F.O.R. destination in Himachal Pradesh F.O.R. for Kinnaur, Lahaul & Spiti and Pangti is upto Rickong Peo, Manali & Chamba respectively.
2. 100% payment will be made within 21 days against physical delivery of inspected/accepted stores duly supported with satisfactory inspection note and after receipt of correct goods at consignees site/destination.
3. The goods will be inspected before dispatch by the consignee or his authorized representative and the inspecting officer will in his inspection note certify that the same are conforming to the specifications/sample lying with the supplier.
4. The delivery of the material will be made within 45 days from the date of receipt of supply order.
5. The above rates have been approved keeping in view the fact that the unit is a small scale industrial unit and as such the material supplied shall be manufactured in the unit itself and not arranged from outside Himachal Pradesh or any other source otherwise it will constitute a breach of rate contract.
6. The Cement Hollow Blocks should be manufactured with hydraulic pressure compression machine and concrete mixture.
7. The hollow concrete block should have mix proportion 1:3:6 (1 Cement 3 Sand and 6 Hard Stone ballast) with 20mm down gauge like wise solid concrete block having mix proportion 1:4:8 (1 Cement 4 Sand and 8 hardstone ballast) with 20mm down gauge.
8. The minimum compressive strength of hollow concrete blocks having mix proportion as 1:3:6 should be 70 kgs/cm<sup>2</sup> likewise the solid concrete block having mix proportion 1:4:8, should have minimum compressive strength of 85 Kgs/cm<sup>2</sup>.
9. The above blocks should be load bearings.
10. The VAT will be charged extra as and if applicable.
11. The other conditions as mentioned in the enclosed Schedule "C".
