No.154/HP/2010/EPS- In exercise of the powers conferred by sub section (1) of Section 13A of the Representation of the People Act, 1950 (43 of 1950) the Election Commission of India in consultation with the Government of Himachal Pradesh hereby nominates Sh.Manoj Kumar, IAS(HP:88) as the Chief Electoral Officer for the State
