Essential Qualifications:-

1. 10+2 or its equivalent from a recognized University/Board.
2. Successful training of at least 2 years duration in Ayurvedic Pharmacist/Compounder or B.Pharm/D.Pharm (Ayurveda) recognized by the H.P. Takniki Shiksha Board/University recognized by the State Govt.

Desirable qualification:-

Knowledge of custom, manners and dialects of Himachal Pradesh and suitability for appointment in peculiar condition prevailing in the Pradesh.

AGE:

The applicant should not be less than 18 years and not above more than 45 years as on 1.1.2012. The upper age limit is relaxable as per instructions of Govt. of H.P.

Other conditions:-

1. The above posts are to be filled up on the contract basis in the Department of Ayurveda.
2. The candidates may be appointed at any where in the Pradesh.
3. The application should be bonafide resident of H.P.
4. The application form complete in all respects from the eligible candidates must reach in the office of Director of Ayurveda, H.P. Block No. 26, SDA Complex Kasumpti on or before 28.11.2011 in case of non-tribal area (on or before 7.12.2011 in case of Keylong, Udaipur, Kaza, Pooh, Dodrakawar and Bharmour areas). No application shall be entertained after the aforesaid last dates.
5. The applicant will have to submit complete following documents.
 1. Education Qualification
 2. Age
 3. Category

6. Disqualifications for admission to the examination:

No person shall be eligible for admission to the examination:-

- a) if he/ she has been dismissed from any previous service;
- b) if he/she has been convicted of any offence involving moral turpitude or has been bound down for good conduct under the provisions contained in Chapter VIII of the Code of Criminal Procedure, or has been or selection.
- c) if he/she is found either directly or indirectly influencing the selection process in any manner;
- d) if he is a man, has more than one wife living and if a woman, has married a man already having another wife; or
- e) if he/she is an un-discharged insolvent.

Every person applying for appointment to the service, at the bottom of the prescribed application form, shall give a declaration that he does not suffer from any of the aforesaid disqualifications and also that he conforms to all the eligibility criteria. The declaration shall also contain his undertaking that if the same is found false or incorrect, his candidature shall be liable to be cancelled or if appointed, his appointment shall also be annulled.

7. Last date for receipt of applications:

The last date for receipt of applications, complete in all respects, is 28.11 2011 in case of non-tribal area (on or before 7.12.2011 in case of Keylong, Udaipur, Kaza, Pooh, Dodrakawar and Bharmour areas). No applications will be received or entertained after these dates.

8. How to apply:

- i) Download the application form from the website applicable to the candidate.
- ii) The latest attested coloured passport size photograph be fixed on the application form.
- iii) Mention clearly the post applied for viz. Ex-Servicemen/ PWD.
- iv) Reserved category should be mentioned clearly.
- v) Attach all the required certificates.
- vi) Retain a photocopy of application for future reference.

9. Admission/ rejection of candidature:

- (i) Applications submitted in the proforma which is not prescribed, improperly filled up, defective applications or applications received after above dates shall not be entertained or shall be rejected straightway without provision opportunity for corrections. Therefore, it is in the interest of the candidates to fill up the applications carefully, submit them with required documents/ photographs well in time.
- (ii) The eligibility of the candidates will be determined on the basis of Department of Ayurveda Recruitment & Promotion Rules for the post of Ay. Pharmacist and instructions by the Govt. as well by the Department of Social & Justice Empowerment from time to time for filling up these posts. The eligibility of candidates called for interview will be determined on the basis of

original documents and the department will not be responsible if the candidature of any candidate is rejected at that stage or at the time of verification by the selection committee. As such admission to the interview shall be purely provisional.

- (iii) Onus of proving that a candidate is eligible to apply for the post is on the candidate only. If the date of notification/ declaration of result is not indicated in the degree/ certificate/ marks list, the date of issue of degree/ certificate/ marks list shall be deemed as date of acquiring essential qualification.
- (iv) The candidates claiming reservation must submit valid certificates of concerned category in support of the claim. In case of invalid certificates, the application will be rejected. The category once claimed shall not be changed.

if you belong to OBC category you are required to produce OBC certificate, which should not be more than two years old at the time of last date fixed for receipt of applications, viva-voca, alongwith latest affidavit duly attested by the authority authorized under the Indian Oath Act stating that your status as OBC has not changed and you are not excluded from the category of OBC on account of being covered under creamy layer. Such certificate should be based on the lineage of parental family. You will not appear in the examination or viva-voca, if you fail to bring both these documents. No further time will be given for submission of these documents after viva-voca.
